Furthermore, any right, title, or interest that I may have in such horse shall terminate at that time.

As additional consideration for the adoption of said horse, I hereby remise, release, hold harmless, and forever quit claim unto assigns, any and all actions and manner of actions, causes of actions, debts, dues, claims and demands against **Saffyre Sanctuary, Inc.** or its agents or employees, arising out of, or in any way relating to, any actions or behaviors of this adopted horse, whether or not occurring as a result of or omission of **Saffyre Sanctuary, Inc.**, or its agents or employees actions in treating or delivering said horse. Additionally, I hereby consent and agree to release **Saffyre Sanctuary, Inc.** of any and all liability arising from the adoption and delivery of aforementioned horse from the date of this agreement.
