In consideration for the efforts that SAFFYRE SANCTUARY, INC. will put forth to find the above equine an adoptive or foster home, OWNER agrees to the following:

- 1.) During the duration of this agreement, OWNER will own, continue to provide for, and be liable for all costs, fees, and conditions associated with the proper care and maintenance of above equine.
- **2.)** SAFFYRE SANCTUARY, INC., at their sole time and expense, will provide advertising, reference checks, screening, site inspections and any other service necessary to ensure that above equine is placed in a SAFFYRE SANCTUARY, INC. approved adoptive or foster home.
- 3.) OWNER will transfer ownership of the above equine, to SAFFYRE SANCTUARY, INC. in the event an adoptive or foster home is located through any effort put forth by SAFFYRE SANCTUARY, INC., including but not limited to any advertising, phone conversations, web links, any media in any form, connections and/or communications that occur between friends, family, relatives or other persons, used to promote locating a home for above equine, and placement is successful through such efforts.
- **4.)** OWNER will permit and consent to SAFFYRE SANCTUARY, INC. charging and collecting a rehoming fee from the adopter. This fee will be set and determined by SAFFYRE SANCTUARY, INC.
- **5.)** OWNER is prohibited from "selling" the above equine to any prospective adopter or foster that SAFFYRE SANCTUARY, INC. has contacted or located through any SAFFYRE SANCTUARY, INC. efforts.
- 6.) OWNER releases and holds harmless, SAFFYRE SANCTUARY, INC., any of its owners, agents, directors, employees, volunteers, or any and all persons associated with SAFFYRE SANCTUARY, INC. from any incident that may arise from SAFFYRE SANCTUARY, INC. providing and giving out OWNER's contact information, and, any injury or liability that may occur to OWNER or any persons, equines, or pets, as a result of prospective adopters or fosters visiting OWNER's property, or property where above equine is located.
- 7.) If SAFFYRE SANCTUARY, INC. does not find an adoptive or foster home for above equine within <a href="mailto:one-year">one-year</a> from the date this agreement is signed, or if OWNER is able to locate an alternative home for above equine by their own means and efforts, this agreement is cancelled, considered null and void, with no further obligation between OWNER and SAFFYRE SANCTUARY, INC.
